VISIONCORPS MISSION TO PROVIDE THE TOOLS FOR GREATER INDEPENDENCE IS PARTIALLY ACHIEVED BY PROVIDING EMPLOYMENT OPPORTUNITIES FOR PEOPLE WHO ARE BLIND IN BOTH THEIR MANUFACTURING AS WELL AS SERVICES DIVISIONS. THE NATIONAL UNEMPLOYMENT RATE FOR PEOPLE WHO ARE BLIND IS 70% WHICH IS WHY, AT VISIONCORPS, PEOPLE WHO ARE BLIND ARE FIRST CONSIDERED FOR EMPLOYMENT FOR POSITIONS WHICH THEY ARE ACADEMICALLY OR VOCATIONALLY ABLE TO PERFORM AT THE HIGHEST STANDARDS. NO LESS THAN 75% OF DIRECT LABOR PERFORMED AT VISIONCORPS IS DONE BY EMPLOYEES WHO ARE BLIND. PROVIDING MEANINGFUL, WELL COMPENSATED EMPLOYMENT FOR PEOPLE WHO ARE BLIND IS A TOP PRIORITY AT VISIONCORPS.
